
PRELIMINARY PLAT SPRUCE SUBDIVISION



Recommendation & Proposed Motion

The Planning Commission should hold a public hearing, accept the findings, and recommend approval of the proposed plat with the following stipulations:

1. The final plat shall be in substantial conformance with the preliminary plat received May 19, 2020
2. All public improvements shall be installed as required by the City Engineer.
3. The civil construction plans shall meet all requirements as determined by the City Engineer.
4. No access to lot 4 shall be provided from SR92 / Timpanogos Highway. A one-foot NVAE easement shall be added to the south lot line and a note shall be placed on the plat
5. The 20' Sanity Sewer and PUE demonstrated on Lot 4 shall be a dedicated open space public utility parcel dedicated to the City or an alternative location approved by the City Engineer that is located within city owned property or right of way.

I move that the Planning Commission accept the findings and recommend approval of the Preliminary Plat subject to the five (5) stipulations recommended by staff.
