PUBLIC SAFETY REMINDERS FOR WARM WEATHER

Summer is quickly approaching and many of us are ready to move out of winter's colder temperatures. Our workload takes a different perspective at the beginning of summer and when school dismisses. The following are items taking a large amount of police resources to address:

VEHICLE BURGLARIES. This type of activity has increased. The vast majority of these recent cases have been solved and we have recovered much stolen property. Almost every incident involved theft of items from vehicles that were not locked! The offender(s) simply tried to open vehicles parked on the street or in a driveway. When a vehicle was found to be unlocked, they canvassed the interior for items of value. In several vehicles the garage door opener was used to open the garage and items were taken from garages after gaining access. These burglaries normally occurred between midnight and 4am. ***Please lock your car*** no matter how "safe" you consider your neighborhood.

ATVs or OHVs (Off Highway Vehicles) become an issue as the weather warms. ATVs and OHVs, as well as other unauthorized vehicles, are not allowed on ***any*** city trail or open space even if the property is not posted. An area of concern is the NW portion of Highland City near the Beacon Hill development, the Twin Bridges area and the area where Highland and Alpine City share a common boundary. For many years people rode horses, ATVs, dirt bikes, sighted in rifles, and did shooting in this area, however the area is now within the city limits of either Highland, Alpine or

Draper & such activity is now prohibited.

PETS. Leash laws in Highland require dogs be on a leash when they are off your personal property. Also, as a responsible pet owner & per city ordinance, you shall clean up droppings from your animal on other property, including trails, parks, sidewalks, & streets. Concerns have been raised by others using public open space & trails about these issues.

ILLEGAL DUMPING. There is an increase in this problem, specifically in the northwest area of Alpine's city limits known as "Hog Hollow". Much of this area is not developed and contains many hills and depressions. The monies paid to mitigate these issues could much better be used in other areas of the City's budget. We are asking any of the residents of that area to notify us when observing these activities in progress.

GRAFFITI. There has been an increase "tagging" incidents in all of Utah County. Commonly referred to as "graffiti", this is also an illegal act which is charged as criminal mischief, destruction of private or public property, and often includes a charge of trespassing. Resources used to address and correct this illegal act could better be used in other endeavors.

We police two great communities. As your police department it is our goal to keep communities safe and enjoyable. We need your help as additional eyes and ears. If you see any illegal activities occurring, please call Central Dispatch at either 343-4100 or 375-3601 to report it.

Violation of this ordinance is punishable with a Class C Misdemeanor and up to \$250 per sign, per day or up to 90 days imprisonment per sign, per day.

LANDSCAPING REQUIREMENTS REMINDERS

According to Highland City ordinances, all residents are required to landscape 70% of their front yard within 1 year of occupancy. (occupancy date is when final inspection was completed on your home.) Your park strip must also be landscaped consisting of 50% living material and 50% specified non-living material. Requirements for vegetation and non-living materials can be accessed through the city website. For those that have not yet completed landscaping and have

surpassed the one year warranty period your landscaping must be complete by June 1, 2008. Unfortunately, those in violation after this date may be issued a citation. Complete landscaping means exactly 70% of the front yard and park strip fully landscaped. Complete does not include landscape plans and/or landscaping in progress. **It is important to know there will be no exceptions.**

Some of the most common problems that occur during

landscaping are:

1. Dirt/debris in right of way. The right of way consists of sidewalk, park strip, curb, gutter, and street. No dirt shall be allowed for any amount of time. Piles of rock and dirt may be dumped on your property including your driveway.
2. Dirt/debris & vehicles on open space. If your home abuts open space, it is unlawful to use this land to access your property.

3. Broken Sidewalks. This is the homeowner's responsibility. Be sure that landscapers protect the sidewalk if they are driving across it. Gravel ramps may be put down for protection, but no dirt of any kind may be used.

If the above violations are observed citations may be issued. Please ensure your landscapers are aware of city regulations to prevent code violations.

CEMETERY NEWS! BRICK PAVERS AVAILABLE

Full completion of the Cemetery is planned for this Summer! Watch for coming details on an exciting Veterans Day Celebration to honor our veterans and commemorate completion of the cemetery this November. As part of the cemetery project, "brick pavers" in the veterans memorial area can be purchased for \$100 each. Pavers are a great way to memorialize your veterans or ancestors. The pavers are a 6" x 10" gray granite block.

Also, in May the City Council will determine if Cemetery fees will increase. An independent study done on the fees recommends increases to lots sales and other cemetery fees. Watch for details in the June newsletter. Prior to the fee increases the City is offering financing of cemetery lots through your Utility Bill. You may also pay with a credit card.
